# Information:

- Down the Hall highlighting the enrichment opportunities provided by classroom teachers throughout the school this month.
  - The students are loving the splitting of the class for small group instruction. I have already seen the benefits in understanding concepts as well as with behavior. We have been marking vowels and learning special sounds. These are major concepts that are learned to help in decoding words for reading.
  - 1st grade has been as busy as Santa's elves. They read the book, "How to Catch an Elf" and then used their engineering skills to build elf traps during STEM time. A merry time was had by all thinking outside of the box and working cooperatively in a group.
  - 3rd Grade had been discussing story structure. They are in the process of creating their own short Christmas themed story. They are developing characters, setting, and the plot. At the end they will put their story in a book and do illustrations. Additionally, we are doing a STEM project that will allow

students to make a Christmas tree that spins using Magnets, wire and AA batteries!

- Last week the 6th graders went to a crime scene. There were 5 body outlines and several pieces of evidence marked. The student had to try and figure out what had happened. After they made their guesses, we went back to the classroom and discussed the Boston Massacre. We looked at what both sides said happened and compared. The kids had a great time and it was fun to listen to their guesses as to what happened. The 8th grade girls helped Mr. Mann set up the scene.
