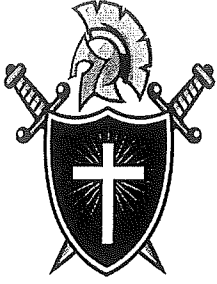


# VISIONWAY CHRISTIAN SCHOOL TUITION CONTRACT

The following policies are set forth by the VisionWay Christian School Board. If other arrangements need to be made, they must be submitted in writing and sent to the VCS Administrator. The school board will respond within 30 days. You will then be notified by the Administrator of their response.

- \* **VisionWay students will not be allowed to attend class if tuition becomes past due by more than 30 days.**
- \* Registration and Material Fees are non-refundable and due at time of enrollment and re-enrollment.
- \* A student will not be allowed to return to VCS if there are any financial obligations remaining from the previous school year.
- \* Transcript/diploma or other school information shall not be issued until all financial obligations have been met in full.
- \* Due to general expenses and staff commitments, no reduction can be made in tuition due to absenteeism, school closings due to inclement weather, scheduled days closed for holidays, teacher workdays, etc.
- \* Lunch fees and school-age extended care are optional services; therefore, each service has a separate charge and is not included in your tuition payment.
- \* **A fee of \$25.00 will be charged to your account for returned checks or drafts made payable to VCS.**

The payment plans offered for the 2025-2026 school year for tuition are as follows:

**Plan I** - Single payment for the entire year's tuition is due by August 1, 2025. A \$25.00 late fee will be applied after the 10th.

**Plan II** - Two payments - 50% of entire year's tuition is due on August 1, 2025 and remaining 50% is due by January 1, 2026. A \$25.00 late fee will be applied after the 10th.

**Plan III** - 10-Month Payment Plan - This plan allows budgeting of school tuition over 10 months beginning August 2025 and ending May 2026. Each month's payment is due by the 1st of each month, with a \$25.00 late fee applied after the 10th of each month.

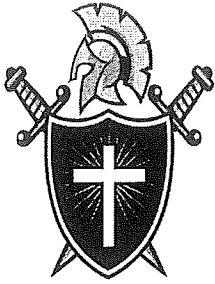
